CRISIS INTERVENTION

Crisis intervention is provided in person, via SMS text, online chat, and our crisis hotline 24 hours a day, 365 days a year. Advocates assess the caller's safety, provide crisis intervention, and empower the victim to develop a safety plan and a plan of action based on their individual needs. Advocates will also provide victims' rights education and information about community resources.

EDUCATION

To ensure victims are receiving comprehensive services, advocates undergo extensive training. An emphasis on education prepares advocates to be equipped with the necessary knowledge and skills to utilize best practice techniques to serve victims to the fullest extent. Victim Assistance Program provides ongoing education to staff, volunteers, interns, and community professionals through our own Summit Victim Assistance Academy. The Academy currently offers a 40 hour course The Essentials of Victim Advocacy 6 times per year alongside fee for service customized trainings to professionals.
